Generators **MUST** be of the Quiet type(Honda, Kipor, etc). **Loud Worksite generators WILL NOT BE PERMITTED. There will be NO EXCEPTIONS.**

- This is a BBQ Brethren event utilizing the KCBS format. It is KCBS Sanctioned and part of the Empire State BBQ Championship. It is a qualifier which will require 25 teams. All KCBS official rules will be in effect. Rules can be downloaded here.

- The minimum requirement for category submission is 6 separate and identifiable portions. 8 portions are suggested. These portions are for judging purposes.
- **NEBS Grilling Event Overview: \$50 entry fee.**
  - **Categories TBA**
- \$\$ Awards will be given for Grand Champion, Reserve Grand Champion and first in every category. Ribbons to 3<sup>rd</sup>
- **All Entry fees are returned to Prize pool minus Sanctioning fees.**
- **KCBS Championship. \$250 entry Fee.**
  - 4 Categories
  - Chicken
  - Ribs
  - Pork
  - Brisket
- Trophies and cash for GC, RGC and First thru third place in each category. Ribbons to 10<sup>th</sup>. Subject to expand based on >35 teams.
- **All Entry fees are returned to Prize pool minus Sanctioning fees.**
- Each team will be provided a space that is approximately 20' by 20'. A limited number of 25x30 Premium spaces will be available.
- There will be a NEBS grilling contest on Saturday. Rules will be posted on the contest website and the BBQ Brethren Forums.
- Please respect the park's neighbors. Quiet hours will be enforced.
- The Maples has a full outdoor bar and patio with tap beer and beverages. The bar is attached to the contest site. **In lieu of their generosity, IT IS HIGHLY ENCOURAGED THAT WE USE OUR HOSTS FOR OUR BEER AND BEVERAGE SOURCE.** They will have tap beer available at the outdoor bar and a beer trailer on the contest site.
- The Waiver of Liability and the Entry Form must be submitted with your payment.
- All teams are responsible for being in compliance with KCBS rules and Suffolk County Dept. of Health codes if applicable(for vendors).
- Trash must be removed by each competitor (dumpsters are available)

- Restroom and Porta-Johns will be available
- Please bring 100' of extension cord if you desire an electrical hookup (10amp max – no refrigerators, etc.)
- Water Grid available. Bring 50-100' of hose and Y connector
- **Please bring separate containers for grease and ashes**
- Sanitation (wash, rinse, disinfect) will be checked at meat inspection.
  - Proper storage of meat is required. It must be maintained below 40F or above 140F
- If you would be interested in conducting a demo for the public on the art of “Low and Slow’ BBQ, or anything related, please let us know.
- Any changes to arrival, set-up, and breakdown instructions with schedules will be sent to you via email when your payment, entry form, and signed liability waivers have been received.
